D.NOTES

If you are receiving one of the following benefits, your child can have a Free School Meal.

- Income Support (IS)
- Income Based Jobseekers Allowance (IBJSA)
- Child Tax Credit, provided you are not entitled to Working Tax Credit and have an annual income (as assessed by Her Majesty's Revenue and Customs (HRMC)) that does not exceed £16,190.
- Guaranteed element of State Pension Credit
- Employment & Support Allowance Income Related (ESA)
- Support under part VI of the Immigration and Asylum Act 1999
- Where you are entitled to Working Tax Credit during the four week period immediately after your employment ceases, or after you start to work less than 16 hours per week, your child is entitled to Free School Meals
- Universal Credit

Examples of Proof:

Proof of your National Insurance Number

- Proof would include things like your National Insurance number card, payslips or letters from the Department of Work and Pensions or the tax office.

Proof of your income – **Proof should be no more than 3 months old and the address should be the same as the one in your child's current school record.**

- A recent letter from the Department of Work and Pensions saying you get Income Support or Income Based Jobseeker's Allowance
- Other recent proof that you are getting Income Support or Income Based Jobseeker's Allowance, or the section below completed and stamped by the Job Centre Plus.
- A Tax Credit award notice from Her Majesty's Revenue and Customs (form TC602 or M1000)
- Documents or official letters providing you are getting support under Part VI of the Immigration and Asylum Act 1999.
