GCSE Results Day – Thursday 25 August 2022

I would like to update you with important information regarding the publication of the examination results on **Thursday 25 August 2022**. All result envelopes will be available for distribution and collection from the Agora between **10.00am** and **12.00noon** on **Thursday 25 August 2022**. Results can be collected by the student in person.

If your child is unable to attend on results day and wishes to authorise a designated person to collect their examination results envelope (including parents / carers), they must confirm this in writing. Please ensure the person responsible for collecting the results envelope brings the completed form attached with them on the day, together with ID; unfortunately, we will not be able to release results without written consent. Please be aware that we **will not** be able to communicate results over the telephone or by email.

Note that it is critical that the attached form is completed and returned by Friday 15 July 2022 to ensure that your results can be collected by your Designated Person on results day if your child is unable to collect their GCSE results on Thursday 25 August 2022.

Any uncollected results envelopes will be posted home after 2.00pm on the day. It is therefore vital that the address held by Oasis Academy Mayfield for your child is correct. Please inform us **immediately** of any recent home address changes.

Members of the Senior Leadership Team, teaching and support staff, as well as local post-16 specialist staff, will be available on results day to help students with any queries that may arise. Please remember we will be making this a very special event where the students can celebrate all their hard work and achievements, and refreshments will be available. We envisage a great day and we look forward to welcoming our students, together with their parents / carers back to the Academy on results day.

Further details on the arrangements for the day will be shared before the Academy closes for the summer break. We want to take this opportunity to thank you for your continued support and we hope that your child is relishing the opportunity to rest after a gruelling GCSE examination season.
